## 6. Accidental release measures

<b>Personal precautions, protective equipment and emergency procedures:</b>	Avoid build up of vapour. Ensure sufficient supply of air. Avoid contact with eyes or skin. Contact with water - danger of sliding. Wear appropriate personal protective equipment and clothing to prevent exposure. Increase ventilation. Evacuate all unprotected personnel.
<b>Environmental precautions:</b>	If leakage occurs, dam up. Prevent surface and ground-water infiltration, as well as ground penetration. Prevent from entering drainage system. If accidental entry into drainage system occurs, inform responsible authorities.
<b>Methods and materials for containment and cleaning up:</b>	For large spills: Remove with vacuum truck or pump to storage/salvage vessels. For small spills: Soak up residue with an absorbent such as clay, sand or other suitable material. Place in non-leaking container and seal tightly for proper disposal.

<b>Precautions for safe handling:</b>	Containers, even those that have been emptied, may contain explosive vapours. Do NOT cut, drill, grind, weld or perform similar operations on or near containers. Electrostatic discharge may be generated during pumping - this may result in fire. Ensure electrical continuity by bonding and grounding (earthing) all equipment.
<b>Conditions for safe storage, including any incompatibilities:</b>	Do not store in open or unlabeled containers. Store in a cool, dry place with adequate ventilation. Keep away from open flames and high temperatures.
